LMSD Board of School Directors Business Meeting Highlights

Nov. 19, 2018, Business Meeting

SUPERINTENDENT'S REPORT

Mr. Copeland yielded the floor, so that the Board could discuss and vote on a proposed Agreement of Sale for properties at 912, 916, 920 and 922 Spring Mill Rd. in Villanova. Purchase of these properties would give the District space for fields to be used in conjunction with a new middle school for grades 5-8 at 1860 Montgomery Avenue. The purchase price is \$5.2 million and the agreement is contingent on the Township approving changes to the zoning ordinance for public schools, along with due diligence surveys of the land. The Board approved the Agreement of Sale, which took Stoneleigh out of consideration for middle school fields. (Later that night, the Township Board of Commissioners approved the ordinance change, which the District had requested).

AUDIENCE RECOGNITION

A Wynnewood resident asked whether the properties on Spring Mill Road are contiguous to the 1860 Montgomery Avenue site or whether students would need to be bused to the fields. She was informed that the fields are a 5-6-minute bus ride from the proposed middle school site.

Facilities and Operations - Item I

At this time the motion to approve the Superintendent entering into the Agreement of Sale for the Spring Mill Road properties was taken. The motion was Board approved 9-0.

After this vote, Dr. Gilbert turned the chair over to Mr. Driscoll, so that she could attend the Board of Commissioners meeting and provide information on this matter.

PRESENTATION

Mr. Weinstein, Principal of Harriton High School gave a presentation on the Student Leadership Conference that was held in May. Sixty students (30 from each high school), selected by club advisors, coaches and teachers, spent the day together engaged in community-building, leadership development and activities to empower student voice. These students also looked at the results of the Challenge Success Student Survey and shared their thoughts on issues such as homework and stress. High School staff are now shadowing these students and others to learn more about their lives in and out of school and the group will reconvene to further discuss issues and plan events over the course of the school year.

SUPERINTENDENT'S UPDATE

Mr. Copeland shared the following updates:

- Congratulations to the Harriton Girls Varsity Tennis Team, who won their second state title in three years. The team had an impressive 20 and 0 season.
- Members of the Lower Merion High School crew team won two first place finishes in the two-kilometer sprints at the Bill Braxton Memorial Regatta the final regatta of the fall season. Congratulations to the Novice Girls 4+ and Novice Boys 8+.
- Our high school students had two successful productions this past weekend. The Harriton
 Theater Company presented "Sherlock Holmes" and the Lower Merion Players presented
 "UrineTown."
- A Penn Wynne Elementary school student will be appearing in "Matilda" at the Walnut Street Theatre.
- Four community members came out for the second "Ask the Superintendent" session this weekend, where we discussed gym requirements, college counseling and sleep and start times.

HUMAN RESOURCES

The Board approved personnel actions across the District, including staff hires, re-hires and reclassifications for the 2018-2019 school year.

Dr. Vann Lynch reported on the November 7, 2018, Curriculum Committee Meeting, where the committee heard presentations on the Comprehensive Plan, the Gifted and Talented Program Evaluation and the Sleep and Start Time study.
