#### SUPERINTENDENT'S UPDATE

As Mr. Copeland, along with Mr. Hughes and Mr. Weinstein, had already recognized the National Merit students, no further update was given at this time.

#### HUMAN RESOURCES

The Board approved personnel actions across the District, including staff hires, re-hires and reclassifications for the 2019-2020 school year.

The Board recognized the passing of Mr. William Brubaker, who served the District as a social studies teacher at BC Junior High, assistant principal at BCMS, acting principal at Narberth Elementary, assistant principal and principal at WVMS and principal at Cynwyd Elementary from 1962 until his retirement in January 2000.

# **EDUCATIONAL SERVICES**

Dr. Vann Lynch reported on the Oct. 8, 2019, meeting of the Curriculum Committee, where the committee reviewed the contracts with Dr. Bena Kallick, who is consulting with the District's work on elementary report cards and iTutor, which will provide online tutoring services for the 1:1 Tutoring initiative when face-to-face tutoring is not available. The committee also heard a presentation from Dr. Pratt regarding NoRedInk, which is a program that helps teach grammar and a presentation from Dr. Eveslage about the District's summer programs.
