LMSD Board of School Directors Nov. 22, 2021, Business Meeting Highlights

To start the meeting, Board President Klain thanked the community for the support shared during this past week, since the tragic passing of LMHS principal Sean Hughes. She added that the Board and Administration will work with students and the Hughes family on ways to memorialize Mr. Hughes and his contributions to Lower Merion.

Ms. Klain also thanked outgoing Board members, Ms. Actman, Mr. Driscoll, Ms. Finger and Dr. Gilbert for their hard work and dedication to the District.

SUPERINTENDENT UPDATE/PRESENTATIONS

Ms. Stout revealed the results of the student voting for the Black Rock Middle School colors and mascot. The mascot will be the Black Rock Royals. The school colors will be black and gold with a highlight of purple. Approximately 85% of the students who will attend BRMS took part in the voting. They selected Royals because it goes with the BCMS Knights and WVMS Dragons and because Royals are "strong, welcoming, smart and spectacular."

COMMITTEE MEETING REPORTS

Lower Merion High School Student School Board Representative Emmi Wu spoke of how students at LMHS shared stories about Mr. Hughes and are supporting each other. She said the student council will be collecting ideas for a commemoration of Mr. Hughes until after Winter Break, when they hope to begin to work with the administration on how to honor him. Though there is currently a lull in activities, Players did have their show.

Harriton High School Student School Board Representative Eli Feldman said that Mr. Hughes's passing also affected Harriton and HHS students wore black on Tuesday in support of their friends at LMHS. Participation in this effort was very high. He also reported that the Made on the Main Line event raised more than \$1000 for charity. He also shared how the HHS principal's advisory council met with Dr. Mumin. He shared information about the school's Flag Project, the Harriton Theatre Company's show, and the HINK Flag Football tournament. Work is beginning on the annual Dr. Harriton show, which will be February 25, 2022.

Mr. Mooring reported on the Oct. 20, 2021, meeting of the Ad-Hoc Committee on Equity and Anti-Racism, where Dr. Mumin held a meet-and-greet with attendees. As this was the first inperson meeting for this committee this year, an overview was shared about the various Equity task forces and other ongoing Equity work in the District, along with an update on the Equity Audit.

Ms. Finger reported on the Nov. 3, 2021, Curriculum Committee meeting, where the contract with Michael Rettig, who is a scheduling expert, was discussed. Also discussed were teacher training for the Lego First program, the K-4 reconfiguration and reimagining work, the work of the 5-8 committee, and the new plan for world language which will include an exploratory program for 4th graders and daily world language instruction for students in grades 5 and up.

Ms. Actman reported on the Nov. 5, 2021, Policy Committee meeting where the Policies having first and second readings tonight were reviewed.

Mr. Lee reported on the Nov 11, 2021, Facilities and Purchasing Committee meeting, which included review of the following items: the list of bills, the contracts and purchasing report items listed on tonight's agenda and an update on construction of the new middle school.

Ms. Kalish reported on the Nov. 17, 2021, Communications Committee meeting, where the website refresh, the Superintendent's onboarding, the community newsletter, the K-4 and 5-8 committee work, the 5-11 vaccine clinic, bus driver recruitment, and communication regarding Mr. Hughes were discussed.
