Ms. Klain stated that the Board met with Dr. Mumin to evaluate his first year with the District and that he had met or exceeded all of the goals set by the Board. Dr. Mumin expressed his gratitude at being able to serve in LMSD

COMMITTEE MEETING REPORTS

LMHS Student Representative Ms. Wu reported students have settled in, with academics and activities all in full swing. Players will be performing "Beauty and the Beast" in November. Players and the Music Department hosted a fun day for the community. She added that Homecoming is coming up, as is the Radnor Game Spirit Week. The Merionite published its first issue. PSATs were taken by sophomores and juniors.

HHS Student Representative Ms. Simmons reported that Harriton is seeing an increase in school spirit, and activities such as HTC, the Banner, sports and Science Olympiad are in full swing. Harriton is also planning Homecoming and the HTC will be performing "A Midsummer Night's Dream." PSATs were taken by sophomores and juniors.

Mr. Lee reported on the Sept. 28, 2022, Communications Committee meeting, where topics included summer projects such as the District art calendar, videos, recruitment ads and community engagement events; the #LMSDBuildingBelonging campaign; community meetings on full-day kindergarten and healthy start times; and the community newsletter, which is in production. Finally, there will be a pilot of recording committees, beginning with the Ad-Hoc Committee on Equity and Anti-Racism and the Communications Committee.

Ms. Kalish reported on the Oct. 4, 2022, Curriculum Committee meeting where curricular contracts were reviewed and there was a presentation on PAYS survey results. LMSD answers were more favorable than statewide data; however, some areas were identified for further investigation by the District. There was also an update on the Fundations program implementation and a review of the District's summer programs, in which more than 1000 students participated.

Ms. Shurak reported on the Oct. 7, 2022, Policy Committee meeting where the Policies listed for First Readings were reviewed, concentrating on technology devices and student rights and responsibilities.

Ms. Schafmeister reported on the Oct. 13, 2022, Facilities and Purchasing Committee meeting, which included review of the following items: the list of bills, the contracts and purchasing report items listed on tonight's agenda and an update on construction of the new middle school, including some disputed charges and the delayed surfacing the track, which will occur after the end of the academic year to ensure access to the field is not impeded.
